The territory to be annexed is commonly known as Arbor Place of Lisle, 4795 Karns Road, Lisle, and DuPage County, Illinois. All supporting documents have been included. To add this parcel of land to our

rolls, Ordinance 16-01 needs to be approved by the Board of Trustees and then filed with the DuPage County Clerk and Recorder of Deeds.

The territory to be annexed is commonly known as Arbor Place of Lisle, 4795 Karns Road, Lisle, DuPage County, Illinois. Trustee Rieck seconded. Roll Call Vote – Trustee Fisher – Aye, Trustee Flint – Aye, Trustee Hummel – Nay, Trustee Rieck – Aye, Trustee Sehy – Aye, Trustee Wang – Aye The motion passed.

C. Approve Per Capita Grant Application

The Director explained the requirements of the Per Capita Grant and how they have been met. She stated grant funds, should the Library receive them, will be used for electronic access, programs, adult materials and children's materials.
